⁽¹⁾ **Processor Assessment:** The processor assessment is an obligation under the Fluid Milk Promotion Order (7 CFR § 1160.101 et seq.). The Order requires that all persons who process and market commercially more than 3,000,000 pounds of fluid milk products in consumer-type packages in the 48 contiguous States and the District of Columbia on a monthly basis, excluding those fluid milk products delivered to the residence of a consumer, be assessed 20 cents per hundredweight on all marketings of such packaged fluid milk products during the month.

Release Dates Federal Milk Order Price Data

Listed below are the release dates for the Federal milk order program for price data applicable to April 2012 through September 2012. The advanced prices and pricing factors will be released at 3:00 p.m. EST/EDST no later than the 23rd of the preceding month. If the release date does not fall on the 23rd the most current release preceding the 23rd will be used in the price calculation. Likewise, the class and component prices will be released at 3:00 p.m. EST/EDST no later than the 5th of the following month. If the release date does not fall on the 5th the most current release preceding the 5th will be used in the price calculation.
