Total Federal order milk marketings from seven states were compiled for December 1996 through December 1999. The results are illustrated in the following maps and tables. The compilation of this data provides a snapshot of changes in marketing trends within a region or state.

7-State Federal Order Milk Marketings In Review


Combined milk marketings from the seven states (Arkansas, Illinois, Iowa,

Kansas, Missouri, Nebraska and Oklahoma) increased 4.9 percent or 46.2 million pounds from December 1996 to December 1999. Federal order marketings were down in Arkansas, Illinois, Missouri and Oklahoma. Marketings were up in Iowa, Kansas and Nebraska. Several large dairies have begun operations in western Kansas during this time frame.

Depicted by the map below are the counties that comprise fifty percent (based on an aggregation of the largest counties) of the December 1999 Federal order milk marketings from each state. Also provided are the average marketings for each group of counties.


The map on page two illustrates Federal order milk marketings by county for each of the seven states during December 1999 based on the quantity of marketings. The table on page two lists total marketings along with pound and percentage changes by state from December 1996 to 1999. This table also provides the range of marketings per county and the average marketings per county for each state during December 1999.

The table and map on page three provide a list and graphical representation of the counties that increased or decreased milk marketings by over one million pounds from December 1996 to December 1999.
