## Central Order Data: How Did 2011 Measure Up?



Producer prices during 2011 registered significant increases from those recorded the previous two years. The 2011 weighted average statistical uniform price for the Central Order was \$19.19 per hundredweight, a 23.97% increase from 2010's \$15.48 average, and an increase of 64.30% compared with 2009. Since the implementation of Federal Order reform in 2000, the annual statistical uniform price has averaged \$14.36, ranging from a low of \$11.24 in 2002 to the high of \$19.19 in 2011. The weighted average Producer Price Differential (PPD) for 2011 was \$0.82 per hundredweight, which is \$0.23 less than the 2010 average, but \$0.37 higher than 2009 and \$0.16 above the post-reform

Producer marketings on the Central Order averaged 1.161 billion pounds per month during 2011. Central Order marketings totaled 13.938 billion pounds during 2011 -- up 4.39% from 2010, but 25.47% less than the record amount marketed during 2002. Central Order marketings were the 4th highest among all federal orders in 2011, trailing the Upper Midwest, Northeast, and Mideast orders. Producer marketing data by order is depicted in the top right graph on page 3.

Monthly component prices for the last 12 years are depicted by



graphs on page 2. Compared with the previous year, the 2011 protein average

Somatic Cell Value price increased by 28.46%, the butterfat average price increased by 16.19%, and the other solids average price increased by 93.25%. Average Central Order per pound producer component prices, along with the per hundredweight

PPD and statistical blend (uniform) prices, are detailed in the table below. Class I utilization for the Central Order was 32.10% of producer receipts in 2011. The lowest annual utilization was recorded in 2002 at 26.02%, while the Class I utilization percentage peaked in 2007 at 38.82%.




January 2000 - December 2011



#### **Statistical Uniform Price**






#### **Producer Other Solids Price**




### **Total Producer Milk Pooled**




#### **Producer Protein Price**




#### **Producer Butterfat Price**

#### **Utilization Of Producer Milk By Class**





**Monthly Average By Federal Milk Order** 




## **2011 Class I Utilizations**
